- 3) REPORT Borough Attorney reported overall, there are currently twenty (20) residential tax appeals; and because of the current revaluation, the deadline to file an appeal has been extended from April 1st to May 1st. In total, we have thirty (30) tax appeals and that is high already; and he expects to be receiving several more in the coming weeks due to the reassessment. Regarding the litigation of the Rosenblum v. Miele tax appeal and the challenge to the one building/one lot ordinance, we have not heard anything back yet. Mr. Rogan informed the remainder of his report would be provided in Closed Session.

B. BOROUGH ENGINEER

- 1) STATUS REPORT RE SWIM CLUB PHASE II CONTAMINATION INVESTIGATION (Authorized RM 7/9/14) Borough Engineer reported the Remedial Investigation Report has been filed with the NJDEP. The next step would be the Remedial Action Plan (RA) which is the cleanup of the property. A proposal will be submitted for that work in the upcoming weeks for the Council's consideration. A proposal was previously submitted for the next phase of the HDSRF Funding (Hazardous Discharge Site Remediation Fund). He reminded the Borough was awarded \$68,000 for the first phase for the engineering work that was performed for the preparation of the cleanup and that the State would fund up to 75% of the cleanup if the Borough keeps the property as open space or open to the public for recreational use.
- 2) STATUS REPORT RE FOLLOWING PB DEVELOPER'S AGREEMENTS: Mr. DeNicola informed we are still retaining the Performance Bond for the following projects because there are several punch list items including concrete work and paving to be repaired because it was damaged in the winter:

- 3) REPORT RE BOROUGH OF CLOSTER COMPOST FACILITY RECERTIFICATION (Authorized RM 6/22/16) Borough Engineer reported this certification has been ongoing for several years and as long as the County has it, we are still under certification, so we are okay.
- 4) STATUS REPORT RE 2017 ROAD PAVING PROGRAM (Approved RM 5/24/17) INCLUDING NJDOT FISCAL YEAR 2017 MUNICIPAL AID PROGRAM FOR HOMANS AVENUE (SECTION 4) IN THE AMOUNT OF \$165,627 (Approved RM 12/14/16) Notification of award rec'd 3. M.L. 6/1/17 Mr. DeNicola reported he gave the Borough Administrator the final invoice, Change Order and Maintenance Bond from the contractor today and the project came in approximately \$13,000 under budget. It was actually a little bit more but we did that concrete work up on Closter Dock Road by Third Street. This project can be finalized and he will file the paperwork with the State for reimbursement to close it out.
- 5) STATUS REPORT RE BOUNDARY AND TOPOGRAPHIC SURVEY OF WEST STREET BETWEEN WESTMINSTER AVE. & CLOSTER DOCK ROAD FOR AN AMOUNT NOT TO EXCEED \$7,600 (Approval Memorialized at RM 6/28/17) Borough Engineer reported the study was completed some time ago and provided to the Borough; and voiced his understanding the Borough is or will be in negotiations with those adjacent property owners.

- 6) REPORT RE NJ DEPARTMENT OF TRANSPORTATION FOR THE HOMANS AVENUE (SECTION 5) PROJECT (MA-208- Homans Avenue (Section 5) 00020) Approved RM 9/13/17 Notification of Award in the amount of \$220,000 rec'd 5. M.L. 3/1/18 Mr. DeNicola will be requesting a Resolution tonight for the next meeting to authorize Boswell to bid this project. It is from Piermont Road to Anderson Avenue under the DOT grant and on the local portion is Cedar Lane from Knickerbocker Road to Poplar Street and Heaton Court and will include various crack sealing of the roads in the Borough to preserve them a little longer. Instead of resurfacing every 7-8 years, we would extend the life to 9-12 years.
- 7) REPORT Borough Engineer reported he met with DPW Superintendent and the Borough yesterday because we have been having issues with some of the utility companies paving roads and getting trenches repaired. PSE&G has a proposal for Demarest Avenue and Closter Dock Road over the Summer where they will be closing portions of those roads to work on the underground gas lines starting in early May. Suez will be paving Fairview Avenue and a portion of Wellington Avenue because they cut it open last year to repair the lines. Orange and Rockland will be paving the part of West Street where they dug trenches.

At this time, Councilwoman Amitai asked about the paving locations for the 2018 Road Program, and Borough Engineer clarified we will be milling and surfacing those roads included in the program.

At this time, Councilwoman Chung referred to the West Street Survey and asked if the Borough Engineer had a professional opinion as to whether the sidewalk is feasible. Mr. DeNicola said it is possible but the feasibility depends on several factors including costs and the easements required. He informed he had previously provided the rough estimates from the study to the Borough Administrator.

7. <u>REPORTS</u>

A. BOROUGH ADMINISTRATOR

- 1) STATUS REPORT RE FOLLOWING INSURANCE MATTER(S):
 - a. Mail List requests re Insurance:
- 1) <u>Closter Recreation Commission 2018 Summer Concert Series</u> (13d. M.L. 1/25/18): Friday nights @ Closter Lions Band shell/Memorial Park at 7:30 p.m.: 6/15/18; 6/22/18; 6/29/18; 7/6/18; 7/13/18 Borough Administrator reported his office received the list of potential performers and has provided them with the necessary paperwork; and they will continue to follow up on this.
- 2) REPORT RE PREPARATIONS FOR 2020 CENSUS Mr. Dolson reported this process is ongoing and there is a lot of paperwork involved. In response to Councilwoman Chung, he informed he has to verify names and addresses of residents and update as necessary which he will cross-reference with the tax records. In response to Councilwoman Amitai, he informed he has been nominated by the federal government to do this job as it is confidential information.
- the Budget is on schedule for Public Hearing on April 25, 2018. He reviewed it with the Finance Committee and he has invited the non-Finance Committee members of the Council to come review it in the evening on 4/17/18. He wants to be sure everyone is properly informed before the Public Hearing. Councilman Devlin questioned the amendment process; and Mr. Dolson explained any budgeted monies not spent would be collected as taxes and wouldn't be spent; it is not an exact science. He cited Mr. Devlin's earlier comment about Rockland Electric lowering their rates and explained we don't use Rockland; we use another company that is already much lower rates than that so they will not be affected because we have a contract with that company. Mr. Devlin noted there is still \$20,000 additional budgeted this year for electricity that Mr. Dolson is saying is not intended to be used; and asked why the reason would be to collect for that from taxes and not use it. Mr. Dolson explained the taxation and surplus process and noted we use the surplus as a cushion. Our tax levy is only going up 1.64% this year; and if we keep lowering the rate, we can't go backwards because of the levy cap of 2% and an appropriations cap of 2% and we would never get it back.

7. REPORTS (Continued)

A. <u>BOROUGH ADMINISTRATOR</u> (Continued)

3) STATUS REPORT RE 2018 MUNICIPAL BUDGET (Continued)

It is a process that shifts the money and gives us room for expansion in anticipation of rising costs of life, infrastructure issues, etc. He explained that all anticipated revenues have to be available even if we are getting reimbursements for some or all of those expenditures because we have to pay them in full first before being reimbursed. Councilwoman Amitai asked where the additional salaries come from in the event of extra snow storms – is that from surplus. Borough Administrator informed we anticipate that in our snow removal budget and transfer funds to the salary items as needed after November 1st. He said we had to hold onto all unexpended 2017 funds until March 31st in the event there was an unanticipated expenditure that would be paid out of that year's budget to pay those bills. At the end of this year those unanticipated revenues leftover will go into surplus next year. Councilwoman Chung referred to Mr. Devlin's comments on proposed Budget Amendments and asked what the appropriate time would be for same. Mr. Dolson said that if they had any, they could let him know in advance so that they could prepare an answer or address any questions prior to the Public Hearing.

Borough Administrator referred to the Capital Spending Plan and explained it is what we use to purchase or finance large equipment and expenditures; and said he has shown same to the Finance Committee and the other Council members will have the opportunity to review it as well. It is a proposed spending plan that gets introduced after the Budget is adopted; and it doesn't have to be spent just because there are monies in there; it is a proposed spending plan. For example, the Federal Highway Administration has mandated new ADA handicapped accessible ramps which will have to be installed prior to any roads being paved. We are two years behind on having Knickerbocker Road paved, which is a County responsibility; and they are slated to do it shortly, but we have to install those ramps before that can happen and we pay for that then get reimbursed by the County.

- 4) STATUS REPORT RE FOLLOWING GRANTS: Borough Administrator reported there are no changes in the grants except that there is a meeting scheduled between the three (3) communities that participate in the senior transportation program. He will have an update after same.

In answer to the Mayor, Borough Engineer said he is not sure how much the award has the potential to be as it is the first year the NJDOT is offering it; and we are a smaller community than many of the others who have applied for it.

- 4) REPORT Borough Administrator noted the Borough Engineer's earlier request to approve a Resolution at the next meeting authorizing the bidding of the 2018 Road Program. He said he will have a Resolution authorizing the Borough to participate with the County for the ADA ramp project in a shared services agreement.

B. BOROUGH CLERK

- 1) REPORT RE 2018 APPOINTMENTS Borough Clerk reported outstanding appointments not made at the Reorganization Meeting held 1/2/18 are being carried on the Agenda.
- 2) REPORT RE 2018 OATHS OF OFFICE Ms. Castano reported at this time we only have three (3) outstanding Oaths of Office. She asked if Robert Di Dio had attended the last Planning Board meeting to be sworn in. Councilwoman Amitai informed he was unable to attend and he would be sworn in at the next meeting.
- 3) REPORT RE 2018 LICENSES Borough Clerk reported 2018 Borough Licenses are current.
- Ms. Castano explained the Division of Alcoholic Beverage Control should be providing information regarding Tax Clearance Certificates to begin the Liquor License Renewal procedure for the 2018-2019 term. No transfers can be addressed until the renewal process has been completed. At the present time, we have three (3) liquor licenses that will require Special Rulings since they have been inactive: Topside; Retail Holdings; The Hill. Ms. Castano noted she has seen recent activity in the papers regarding The Hill and informed she hoped it would have been completed sooner; but now the owner will have to go through a lengthy process. Mayor Glidden informed the owner had changed his mind about minor renovations and is not undertaking major renovations.
- 4) REPORT RE 2018 MEETING DATES Borough Clerk reported Meeting Dates are current.
- 5) REPORT RE ADOPTED 2017 ORDINANCES TO BE SENT TO GENERAL CODE FOR CODIFICATION Ms. Castano reported we previously sent the Purchase Order to General Code and are now waiting for the Supplement to be delivered.
 - 6) REPORT RE ELECTIONS
- a. PREPARATIONS FOR PRIMARY ELECTION JUNE 5, 2018 Ms. Castano reported we received petitions for Mayor and Council and County Committee by the deadline of 4 p.m. on Monday,

April 2, 2018. She certified the names and e-mailed the forms to the County Clerk's Office/Elections Division by the deadline of April 4, 2018. On the Ballot we have for Mayor, (incumbent) John C. Glidden, Jr. - Republican; and for Council, (incumbent) Alissa J. Latner - Republican; and (incumbent) Jannie Chung - Democrat. She reported as it is an even year, we also received and processed the petitions for County Committee which everyone involved can admit is a challenging process.

The Borough Clerk reported she and Deputy Borough Clerk (Arlene Marie Gray) will be visiting the new polling locations (Closter Public Library and Closter Senior Citizens Center) to compile a list of signs that are needed to so inform the public. In answer to Councilwoman Latner, she explained the Resolution approving the change was published in The Bergen Record; and when she checked online, the change has already been made in the State server. Ms. Castano voiced her understanding that once she compiles the list of required items, she will be sending same to the Board of Education for reimbursement to the Borough as we certainly do not have enough money in our Elections budget to cover these unanticipated expenses. Mayor Glidden agreed that they should cover the expenses and the cost of the necessary signs. Mrs. Latner asked the Mayor to remind the public of same in his next newsletter.

Ms. Castano said in addition to the location appearing on the Sample Ballot, her office will be updating the Borough Clerk's webpage with information. The Mayor said there must be signs at the schools directing the public to the new locations.

7) REPORT - Ms. Castano said that anyone needing assistance with Financial Disclosure Statements can call her office for help to retrieve a username or password.

C. <u>CHIEF OF POLICE</u>

1) REPORT – Chief Kaine reported he sent the monthly report on Monday and invited any questions on same. The Chief wanted to remind residents to lock their cars as there were two high end cars stolen about two weeks ago because they were unlocked with the fobs in them. Last week two cars were broken into and one of them was involved in the Haworth car chase.

The Chief reported the Public Safety Committee met this afternoon with two (2) candidates for PTC Officer and a third sent an email last evening withdrawing the application. He requested further discussion of the top candidates in Closed Session. The written test was held last night; and out of 172 that signed up, only 142 showed up. They hope to have the grades next week.

The Department will participate in the DEA Drug Takeback Program on Saturday, April 29, 2018, from 10 a.m. to 2 p.m. behind Borough Hall. The event will be advertised on social media and the website and the sign boards.

Chief Kaine informed the County plans to straighten out the intersection of Knickerbocker Road/Harrington Avenue/Closter Road/Livingston Street sometime this Summer. The intersection would be closed for a good three (3) months to straighten the road. Borough Administrator informed while he was speaking to a County Engineer this morning on another matter, he was given a more bleak outlook whereas the County plans to stop work in November and return to finish it the following Spring. The Chief noted they have to finish by November for the Eagle sanctuary; and Mr. Dolson said they can't start until July because of the water sanctuary.

At this time, Councilwoman Amitai asked how many of the break-ins were false alarms and the Chief said they were all false alarms. We had zero break and entries. In answer to Councilwoman Chung, he informed our Officers were not involved in the Haworth chase though the proceeds from the break-ins in Closter did end up in the stolen car. We assisted as they crossed Schraalenburgh Road but they never came back into Closter. They ended in Dumont. In answer to Mrs. Amitai, he said the shootings in Englewood resulted from a carjacking; and the State Police arrested them on the Parkway.

D. MAYOR

1) REPORT – Mayor Glidden reported on the following upcoming activities:

This Sunday, April 15, 2018, is the Closter Nature Center Soup Supper at 5 p.m. and he will be contributing his famous chili.

Saturday, April 21, 2018, is the Closter PTO Dinner/Dance at Alpine Country Club at 7 p.m.; and information is available at the Closter PTO.com website. The PTO really puts on a nice affair.

Saturday, April 21, 2018, is the Northern Valley Earth Fair from 11 a.m. to 4 p.m. at Northern Valley (Regional High School) Demarest.

Saturday, April 28, 2018, the Closter Nature Center will hold their ceremony for the winner of the photography contest at 2 p.m. at the Library.

Sunday, April 29, 2018, is the Little League Opening Day Parade at 12:30 p.m. at Borough Hall and proceeding to Memorial Field.

Monday, May 28, 2018, is the Memorial Day Parade. The Mayor and Council will exit the parade at Borough Hall where they will wait to judge the floats. The Mayor's Trophy will be awarded and speeches will be made.

This past Saturday was the town-wide clean-up day and the Mayor thanked everyone who attended and helped out.

The Belskie Museum held their opening for an exhibit called the American Dream – Latino Experience; and he voiced his opinion it is one of the best he has seen; and urged everyone to stop and see it.

8. OLD BUSINESS

Relative to a path from the High Street area to Closter Plaza, Councilwoman Amitai said that there are two paths in the area; and the residents have a mixed feeling as to whether an additional path is needed because one is wide enough for a car and the other by Walnut Street has been there for decades. Some of the residents near the end of the path do not want to see it improved because they don't want strangers in their backyards so to speak, more than there are already. Borough Engineer said using the path leaves walkers on the other side of Vervalen Street where there is no crosswalk for the three-lane road. In answer to Councilwoman Amitai, Borough Attorney said the property was obtained using Green Acres funds; and the Borough Engineer said a buffer of evergreen trees could be planted. Councilman Devlin said he would have the Shade Tree Commission review this area on the south side of Vervalen Street.

Councilwoman Amitai advised that the sub-committee of the Closter Improvement Commission is reviewing the art-box project and Superintendent of Public Works provided of listing of 12 spots to locate the boxes. She said she would provide a listing of the various locations and Borough Engineer said that evergreen bushes must be low so as not to affect the sight line distance.

9. NEW BUSINESS

Councilwoman Latner advised that NVRHS Demarest would be having a Spring Boutique on April 22nd from 10 a.m. to 4 p.m. with all proceeds going to Project Graduation. There will be a number of vendors.

10. OPEN MEETING TO THE PUBLIC FOR ANY MATTER PER NJSA 10:4-12(A) (SUBJECT TO A 5-MINUTE LIMIT PER GENERAL RULE NUMBER 11) EXCEPT FOR ITEMS SCHEDULED FOR PUBLIC HEARING AT THE REGULAR MEETING

Mayor Glidden opened the meeting to the public.

Dr. David Barad, (26 Kinkaid Avenue), advised he had received a letter from Suez United Water offering insurance for a water line which he felt was misleading and should be looked into. Dr. Barad noted that the Borough Administrator has a big job looking up all the finance records and noted that electronic data bases can be used but that census records are not included in the tax records and he would be happy to assist him in this effort. Dr. Barad noted that the Environmental Commission should be made aware of the fact that the Clean Up was held on Passover. Relative to tree planting, Dr. Barad noted that funding should not come from the Shade Tree Commission budget and he recommended establishing a small budget for same.

Steve Isaacson, 97 Columbus Avenue, said when the bus route is changed, the path by Vervalen Street would be a good bus stop; and a traffic light could be installed. He said that the 2020 Census would be a good way to check if the students enrolled in our schools actually live in town. In answer to Mr. Isaacson, Mayor Glidden said that Miele Sanitation is retaining the property and leasing same to IWS. Mr. Isaacson cited the uses that were not permitted on the east side; and Mayor Glidden said we are aware of same in order to address the matter. Mr. Isaacson said the Northern Valley Earth Fair would be held next Saturday and noted that he installed a sign advertising same without official permission. The sign should be up only for a week and a half on railroad property. He asked the Mayor to attend a photo op of Mayors at the Fair. He noted the number of food trucks and participants that will be at the Fair. He suggested that the Clean Up Day, the Sidewalk Sale and the Green Way should be under the auspices of the Closter Improvement Commission. In answer to Mr. Isaacson, Councilwoman Amitai said that the Police Department has no problem with parking at the park on street by the Gas Station at this time but the matter should be addressed after the full impact of Closter Plaza is realized. In answer to Mr. Isaacson, Mayor Glidden said the Diversity Project is quiet at the moment. Relative to the tax rate. Borough Administrator said same comes from the County in the middle of the Summer and is certified by them. Until that takes place, the tax bills cannot be printed. He noted the low spending of the Borough that provided a 2.46% increase. Mr. Isaacson referred to an article outlawing tackle football for children under 12 because of concussions; and Mayor Glidden said if same becomes law, we will not have tackle football.
