Warning by the Closter Police Department

The Closter Police Department is requesting *all* residents and businesses are diligent in their efforts to protect properties. Please set both interior and exterior lights on timers, pick up packages, mail and newspapers and remove valuables from vehicles in driveways. Utilize lighting, set alarm systems and lock vehicles to aid in deterring opportunities that criminals look for. The holiday season is a prime time for scams – phone scams, computer scams door to door scams, etc. Remain diligent and remain very aware by carefully reading emails, reviewing credit card accounts and researching home repair offers. Remember, when an offer sounds too good to be true, there is a good chance it is a scam of some sort.

Above all, remove key fobs from vehicles and lock your vehicles when left in driveways. Remove your valuables from unattended vehicles. You can lesson criminal activity by making it difficult for criminals!
